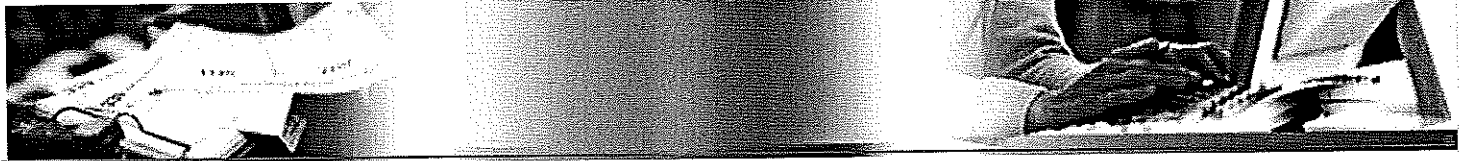

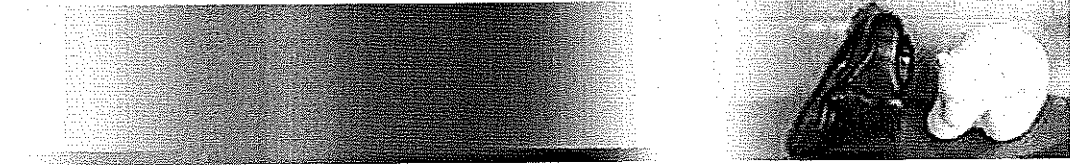
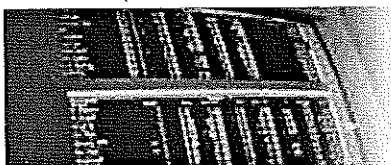

("DISA")**

Equation Corp Limited (the "Company") wishes to announce that its 70% owned subsidiary, M3 Electronic GmbH, has subscribed for 62.5% equity in another Germany entity, DISA. The remaining 37.5% of the paid-up share capital of DISA is held by non-related German partners.

DiSa will be principally engaged in the business of marketing, selling, distribution and development of digital security systems as well as general commercial and technical consultancy. The current intention of DISA is to carry on its businesses in European Union.

DiSa has a registered share capital of €320,000 (approximately S\$675,000).

The investment in DiSa of €200,000 (approximately S\$422,000) was funded by internal sources and is not expected to have a material effect on the earnings per share and net tangible assets per share of the Company for the financial year ended 30 June 2007, the most recently completed financial year.

None of the directors or substantial shareholders of the Company has any interest, direct or indirect, in the above transaction save for their interest (if any) in the share capital of the Company.
